## Year 8 2022 Camp Information

Dear Parents/Carers,

2<sup>nd</sup> May, 2022

As part of the Welfare and Transition Program at Glenmore Park High School, a camp has been organised for Year 8 students to Youthworks Outdoors Conference Centre, Deer Park, Port Hacking. It incorporates both peer support activities and some outdoor challenges designed to help students reach their potential through activities that:

- Develop social skills and independence
- Build team work and a sense of community
- Promote leadership and personal development.

There is an extensive range of activities available, which may include abseiling, dragon boating, sky web (high ropes), rock climbing, archery, and an incredible race. The specific activities will be advised at a later date. The programs foster and build upon the strengths of individuals and will help ensure a rewarding and successful time at Glenmore Park High.

The camp is an excellent opportunity for students to get to know their peers and develop a great working relationship with Year Advisers and teachers. This is achieved in a fun, relaxed setting under the guidance and supervision of qualified venue staff and Glenmore Park High teachers.

The camp runs between **Wednesday 20<sup>th</sup> July to Friday 22<sup>nd</sup> July 2022** Week 1 Term 3. Transportation will be by coach, departing from school early on Wednesday morning and returning Friday afternoon. More details about times, what to bring, etc will be provided closer to the date.

The expected cost of the camp is **\$392**, and is inclusive of all meals, specialised activities, transport and accommodation. This is an experience that will be remembered by all for years to come. Please note that the price has gone up by \$22 due to the increase in the camp organisation's fees.

**Payments must be made in total by Friday 24<sup>th</sup> June, 2022.**

### Payment Options:


1. If you paid in full for the camp in 2021, you will only need to pay the gap of \$22 by Friday 24<sup>th</sup> June.
2. If your child was not planning on going to camp in 2021, but would now like to attend for 2022, you will need to pay the total \$392 by Friday 24<sup>th</sup> June.
3. If your child had planned to go to camp in 2021, but no longer wishes to attend the camp for 2022, you may request a full refund by Friday 24<sup>th</sup> June. 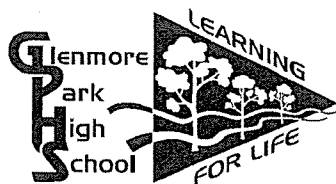

## Year 8 Camp 2022 – Permission Note and Consent Form

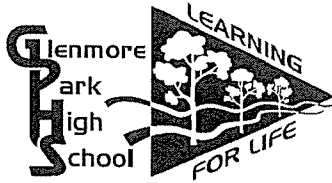

- I am aware of the behavioural expectations and that students are required to complete the activities as part of the mandatory curriculum. I understand that I may be called to collect my child from camp if they have breached camp rules or put themselves or others at risk of injury.
- I understand that if my child receives a *Loss of Privileges* 28 days prior to camp, that their attendance at camp will be discussed on a case-by-case basis and that the decision for my child to attend or not attend camp will be at the discretion of the Principal.
- I understand that my child will **NOT** be able to take their mobile phone to camp.
- I understand the following COVID-Smart Measures and agree to their conditions:
  - My child must produce a negative Rapid Antigen Test 12 hours before their departure to camp.
  - If my child is unwell (including with mild COVID symptoms) they cannot attend camp.
  - If my child develops COVID symptoms while at camp, they will be asked to complete a Rapid Antigen Test, be temporarily isolated and I, as a parent/carer, will need to collect them immediately from camp.
  - If my child shared accommodation with a positive COVID case they will be classed as a higher-risk contact and will need to follow the current NSW Health Information for people exposed to COVID-19 [External link](#).

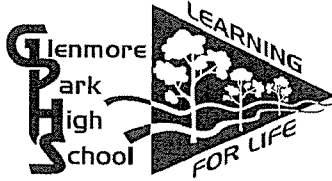
